Remaining payment of the full amount agreed upon will be due within one hour of service hours agreed upon above, unless otherwise specified; therein, the deadline for payment due is 12:00pm (noon) on the seventh business day following the date of service. If payment is not received by 12:00pm on the fifth business day following the date of service, there will be an additional 5% late charge of the full amount agreed upon, \_\_\_\_\_, added daily. Payment is accepted in the form of cash, cashier's check, and/or money order and be made payable to La Verio Barnes. **If mailing send to 520 Mellview Ave, Atlanta Ga, 30310**

The contractee reserves the right to deduct 10% of the full amount agreed upon for each full hour delay of the agreed upon service hour start time. The contractor reserves the right to charge a minimum of 10% of the full amount agreed upon for each full hour past the agreed upon service hour end time. Adjustments may be made and agreed upon for unforeseen changes to the service hour start and end times.

The contractor accepts all liability for usage and maintenance of audio equipment owned by The Urban Legends Djs. The contractor is not liable for injuries that may occur to individuals arising out of the specified event. The contractor will not be responsible for any damages to venue or items loaned for usage during the specified event.
